C1 (age group 13) m/f 300m / 500m // 1000m / Relay

C2 (age group 14) m/f 300m / 500m // 1000m / Relay

Please note: the athletes have to wear ankle protection in a proper way on all distances. None will be provided. They also have to wear their one armband.

Relay: per team one relay male and one relay female
E2 (AK10) to C1 (AK13) 1 lap
C2 (AK14) to B1 (AK 15) 2 laps

The order of the athletes within a relay corresponds to the
respective age groups. The athletes of age group E2 will start
the relay. These athletes have to line up at the starting line for

the start. All following athletes have to start from the outer edge of the outer track into the race.

The exchange zone starts at the 500m start and ends at the main finish.

During the relay races, the following safety regulations must be observed:

- Athletes, who do not take part in this run, are not allowed to stay on the 400m track
- no coaches on the ice or on the infield
- wearing a closed helmet, cut-resistant gloves, cut-resistant neck brace, ankle protection and shin guards is mandatory
- skates must be rounded at the front and back (10 cent piece)

Violation of these safety rules will result in exclusion or disqualification from the relay.

Participants: The competition is open for teams from clubs, regional, national and international selection teams.
According to the valid ISU rules, the participation of Russian and Belarusian athletes in this competition is excluded.

The number of athletes per age group and club is fixed at 2 athletes (1 junior and 1 junior female). If necessary, younger athletes can start max. two age classes higher and female athletes in the respective age classes of male athletes (also max. two age classes higher). We ask for registration of complete teams. **The total number of athletes will be limited to 144 (= 12 teams). The commitment to participate will be made according to the order of registration.**

Scoring: There will be a place-point-scoring. The next placed athletes of another team will receive one point more for the team ranking. The two worst results per team will be deleted. If athletes or relay teams are eliminated, they will be placed last.

Notes

When registering for this competition, personal data is collected or provided from other sources. This data will be used exclusively for registration and the running of the competition and will not be passed on to uninvolved third parties, especially not for advertising purposes. This competition is public, and therefore we will publish the relevant data (first name, last name, location, club, year of birth, competition class) and the results achieved and pass them on to interested media outlets. In accordance with Art. 6 (1) of the GDPR, we inform those affected of this in advance. By registering for this competition, the athlete agrees to the collection, processing, storage, and use of personal data, as well as the publication of registration, starter, and results lists. The results lists are stored for traceability purposes during the competition year and are available for download on the Internet. The athlete may object to this storage in writing (by email to Datenschutz@desg.de). In this case, the personal data will be blacked out or made unrecognizable and the original data will only be published for a period of two months. The email address provided will only be used to send confirmation of registration, for any queries, and to provide information to participants. Note on image rights: The right to one's own image means that every person has the fundamental right to decide for themselves whether and in what context images or films of them may be published (Sections 22-24, Law on Copyright in Works of Fine Arts and Photography, KunstUrhG).
